



SCOTUS - Judge Ketanji Brown

- Biden campaign promise of using race & sex to select nominee.
- History of decisions overturned by higher courts for
 - judicial overreach.
- Jackson might be willing to ignore the law to deliver a particular policy outcome.

SCOTUS - Judge Ketanji Brown

• The most radical judge ever nominated for a seat on the Supreme Court. Record and judicial philosophy reveals a deeply troubling pattern, raises questions about her ability to be a fair and impartial judge.

• Limited judicial record, BUT Jackson has consistently ignored the Constitution, twisting the law to favor certain outcomes. Judges should play a limited role in our government. Jackson's far-left supporters want her to impose a political agenda that invents new rights or erases rights she doesn't like.

America Competes Act (H.R. 4521)

- Promotes Chinese energy over American \$3 billion solar manufacturing program that benefits <u>China's</u> dominance in Solar.
- **Biden regime -** <u>kills domestic</u> mining projects and block oil and gas leasing sales.
- Green slush fund \$8 billion to unaccountable "green climate" slush fund at the UN, which has awarded \$100 million to China, subsidizes the CCP Party and slave labor/genocide solar panels and batteries.
- Climate Change Officers At potentially every U.S. embassy, consulate, and diplomatic mission abroad responsible for focusing U.S. international efforts on climate change policy and programming.

America Competes Act (H.R. 4521)

- Ignores human rights abuses Appeases China omitting "genocide" from provisions on human rights abuses in Xinjiang, despite the House having voted twice to call it genocide.
- Hurts small businesses. Adds burdensome Davis-Bacon requirements, giving unions unfair advantages over small businesses and independent workers. Will significantly jeopardize our ability to compete with China.
- CRT Promotion <u>\$5 million</u> to create a Chief Diversity Officer at the National Science Foundation and direct the NSF to ensure diversity, equity and inclusion in the technology sector.
- CCP can BUY visas New visa program allows Chinese investors (= CCP government) to purchase visas, start a company in the U.S., and then import workers from China with additional visas.
