Leachate Dumping in Young Harris

- NPDES Permit # GA002246 for Water Pollution Control Plant Expired in March of 2022. GA EPD Administratively extended - Addl stricter monitoring with renewal? *MAYBE*
- Obtained testing one and only data for metals, 5/24/22
- EPD: “There is no requirement for the city to submit more data at this time.”
- EPD did not have data that I obtained from Young Harris.

Leachate Dumping in Young Harris

3.7 Million gal over 190 days. Avg 19,500 gallons /day

- Metals Testing: 5/24/22
- Cadmium, Chromium, **Copper**, Mercury, **Nickel**, Selenium, **Zinc**, Arsenic, Lead, all “BDL” except copper (.05/.03) and nickel (.02/.003) and zink .04/.004) (mg/L) **10X allowable.**
- No other chemical, petroleum, pharma substance testing.
- **Not in a hurry to monitor, renew - Time for public action.**

Respect for Marriage Act - **NOT!**

- Real consequence - effect on people of faith and religious institutions.
- Deliberately seeks to attack religious individuals and institutions - Marriage is between one man and one woman.
- Revoke the tax-exempt status of churches.

Respect for Marriage Act - **NOT!**

- Religiously affiliated schools, adoption centers and foster care providers would be forced to close down for the same beliefs.
- Small business owners who choose to only support traditional marriage would be able to be sued under this law.
- Dems refused to hold a public hearing

Lame Duck Spending

- In Sept Congress Passed CR, expires 12/16
- December spending would be vote by Lame Duck Congress.
- Do NOT let Pelosi pass an omnibus spending bill.

Lame Duck Spending

- **New Congress not to be sworn in until Jan.**
- **Pass another short CR until Jan, new Congress is sworn-in. Congress elected by voters in Nov should set the agenda for 2023.**
